Overview



- 2007 was PQRS's 1st year & was a disaster
 - Processing was slow
 - Methodology was cumbersome / required 80% of outpatient visits
- Changes made in 2008 included a 2nd method to qualify which is known as a "Registry Method"
- 2016 regs essentially same as 2015
- 2016 may be the last year for PQRS as a separate program. PQRS is intended to be included in MIPS beginning in 2017.

Overview



- 2014 was the last year for the incentive payment
- 2016 is the performance year for the 2018 PQRS payment adjustment
 - Payment adjustment in 2018 will be - 4.0% for non participation in PQRS / VBM
 - Adjustment to ECs Part B covered professional services under Medicare PFS (Physician Fee Schedule)

Value-Based Modifier



- 2015 was the first year for Value-Based Modifier
 - Requires 50% participation for each practice
 - Does not require GPRO Registration
- Why?
 - CMS wants to make sure that practices are diligently adhering to the PQRS practice philosophy

Registry Method



- VIP has contracted with Covisint for the 7th year in a row!
- At least 20 patients
 - **11 or more must be Medicare**
- Each Measure Group has its own qualifying demographics
- EVERY specialty can use Preventive Care to earn its bonus
- **24 Measure Groups** (see next slide)

Straightforward and easy!!!!

- Ask simple questions of patient
- Enter the data into the Covisint Website
- Completed very quickly

The good news is.... It's NOT too good to be true!

Costs



- **\$199 for Partners Members and Guests**
 - (This is special negotiated pricing. Use coupon code **VIPPQRS** at the end of the submission page)
- Use Personal NPI and Tax ID
- Again, non-participation means a 4% (- 2% PQRS / - 2% VBM) penalty on Medicare Part B collections beginning January, 2018
