PQRS Participation is Critical this Year

Non-participation in PQRS this year means a 2% Medicare penalty in 2017, plus a 2% penalty for non-participation in the Value Based Modifier program. *Last PQRS webinar* – Wed, Dec. 16th!

Meaningful Use Hardship Exemption for 2015 - You are eligible!

Final rules for Meaningful Use 2 were just published on Oct. 16. Due to the late publication, physicians can apply for a hardship exemption for MU2 in 2015, since there isn't enough time to qualify prior to the end of the year.
